    - Emergency Management Plan Change Our plan already includes a cardiac emergency response plan, but that requirement is not listed in the emergency plan policy. Motion to add "AED: The emergency plan is to include procedures for a medical emergency and a written cardiac emergency response plan; the emergency plan is to be provided to first responders and all school staff; and the emergency plan is to be reviewed annually by the school nurse. All these items are found in the Beechwood Independent Approved Safety Plan" and "portable automated external defibrillator (AED)" to the policy: Erin Goetz. Second: Michael Brinkman.
